

LCHS Band Reentry Plan for Parents

Phase 1 (July 6th-July 19th)

- A. Essential personnel only. There are no spectators permitted at any venues until August 15th.
- B. NO CONTACT.
 - a. We will work individual skills and conditioning.
 - b. Social distancing will be practiced (6ft apart).
- C. Groups Sizes
 - a. 15 students per staff member.
 - b. Tracking sheets will be completed daily and submitted to Mr. Smith (Band Director)
- D. Band Room and Instrument Storage
 - a. Instrument storage will not be utilized during Phase 1.
 - b. The Band Room will only be utilized for Percussion. Percussion will be practicing social distancing within the band room.
- E. Restrooms
 - a. One restroom will be open.
 - b. Only one student at a time will be permitted to use the restroom.
 - i. The restroom that will be available is in the fine arts wing.
- F. Face Coverings
 - a. Staff will wear face coverings at all times.
 - b. Students will be required to wear face coverings to rehearsals
 - i. Students may remove them during conditioning.
 - ii. Students will remove them while playing their instruments.
- G. Instruments and Equipment
 - a. Students will be assigned their own instrument (if using a school owned instrument)
- H. Student Requirements
 - a. Must come prepared and leave immediately after. Clothes should be washed prior to the next rehearsal (if wearing the same clothes).
 - b. Bring your own water bottle. We will not provide any nor will they be able to share. A supervised water cooler will be available, however only the supervisor will be permitted to fill bottles.
 - c. Face coverings are encouraged to be worn while not actively participating in the rehearsal. They may choose to wear them during conditioning.
 - d. Students are encouraged to bring their own hand sanitizer. We will have one station available for use.
 - e. Provide honest answers to screening questions asked by staff members prior to each rehearsal.
 - i. Parents and students are asked to check their temperature prior to coming to rehearsal. If it is 100.4 degrees or higher, they should not attend rehearsal.

- I. Transportation
 - a. None provided.

Phase 2 (July 20th-August 14th)

- A. Essential personnel only. There are no spectators permitted at any venues until August 15th.
- B. Contact may begin.
 - a. We will keep this at a minimum, and only for show learning purposes.
 - b. Social distancing will still be practiced when contact is not needed.
- C. Group Sizes
 - a. 50 students per staff member.
 - b. Tracking sheets will be completed daily and submitted to Mr. Smith (Band Director)
- D. Band Room and Instrument Storage
 - a. Instrument storage will be utilized during phase 2. Students will enter at 50% capacity - i.e. Woodwinds enter and leave, then brass will enter and leave.
 - b. The Band Room will only be utilized for Percussion. Percussion will be practicing social distancing within the band room.
- E. Restrooms
 - a. Same as Phase 1.
- F. Face Coverings
 - a. Same as Phase 1
- G. Instruments and Equipment
 - a. Same as Phase 1
- H. Student Requirements
 - a. Same as Phase 1
- I. Transportation
 - a. None provided.

Phase 3 (August 15th and beyond)

- A. Spectators permitted.
 - a. Social distancing will be encouraged.
 - b. Face coverings will be encouraged.
- B. Contact
 - a. Same as Phase 2.
- C. Group Sizes
 - a. Full band will begin rehearsing together.
 - b. No tracking sheets will be collected.
- D. Band Room and Instrument Storage
 - a. Instrument storage will be utilized during phase 2. Students will enter at 50% capacity - i.e. Woodwinds enter and leave, then brass will enter and leave.
 - b. The Band Room will be open as “normal.”
- E. Restrooms

- a. Will be open.
- F. Face Coverings
 - a. Same as Phase 1.
- G. Instruments and Equipment
 - a. Same as Phase 1
- H. Student Requirements
 - a. Same as Phase 1
- I. Transportation
 - a. Provided for all competitions.
 - b. Face coverings will be required.

TRAINING ON SYMPTOMS OF COVID-19

Students and staff [should be trained](#) to recognize the following COVID-19 related symptoms:

- A fever of 100.4 degrees or greater
- Cough
- Shortness of breath or difficulty breathing
- Chills
- Repeated shaking with chills
- Muscle pain
- Headache
- Sore throat
- New loss of taste or smell

Students and staff should be excluded from school if they test positive for COVID-19 or exhibit one of more of the symptoms of COVID-19 based on [CDC Guidance](#) that is not otherwise explained.
